## **CPSI Class Details**



**Location:** The CPSI Course and Exam will be held at the South Kingstown Recreation Center, 30 St. Dominic Road, Wakefield, Rhode Island 02879. The course includes a playground site visit and inspection.

**Certification:** CPSI certification is valid for three years. Individuals who seek their CEPSI certification must take the CPSI exam. Recertification also requires taking the exam. Individuals who wish to recertify are encouraged to attend the CPSI educational course to ensure access to current materials and the latest information on playground safety standards.

Advance Reading: Registration includes a complete set of course materials. The course manual must be studied prior to the start of class on May 2. The exam may include questions about information in the manual which may or may not be covered during the class. NRPA recommends that class participants have at least three weeks to review and study materials in advance of the course and exam. Late registration allows less time for study, which may increase the chance of failing the exam. LISC typically ships class materials within 1 to 2 days of complete registration starting approximatey 60 days prior to the course. Participants who register by March 30 will receive course materials no later than April 10. Registrations received after March 30 must include rush shipping in order to receive materials no later than April 13.

**Class Size:** The CPSI course and exam are each limited to a maximum of 80 participants. A minimum of 25 participants is required to hold the course.

**CEU:** 1.5 continuing education credits are available for full course participants. Sign-in forms will be available during the two-day class.

#### **CPSI Course Registration Includes...**

- Two days of instruction, including a hands-on playground site visit, with expert professionals
- Course materials (provided approximately 1 month ahead)
- Continental breakfast, lunch, and beverages
- Transportation to playground site
- Continuing education credits available

### **CPSI Exam Registration Includes...**

- Administration of the CPSI exam on May 4 from 9:00 to 11:00am
- Three year certification for those who complete and pass the exam

Certification Exam: CPSI certification is valid for three years and is renewable by exam. The certification exam will be given on the morning of Friday, May 4. Two forms of identification are required for the exam. One must be a government-issued photo ID (driver's license, passport, etc.); the second form of ID should contain your name and signature, such as a credit card, Social Security card, work ID (if signed), library card, etc. Notice of exam results will be sent directly by NRPA or its testing agent. Those passing the exam are eligible to be listed in the national CPSI Registry.

Please decide now if you would like to take the exam on May 4, on campus or later via NRPA's Computer Based Exam. Registrants for the June 12 exam will not receive a refund if they later decide to take the exam via NRPA's computer-based testing.
