Provider Spotlight: Emma's Home Day Care



LISC RI recently shared a report on the results of the first wave of the City of Providence Early Learning Facilities Improvement grants. These grants were provided to child care and early learning programs in Providence through a competitive application process. The partnership between the City of Providence and LISC has so far delivered more than \$600,000 in grants and technical assistance to Providence-based providers to improve the quality of facilities. The application for a second wave of funding totaling \$315,000 recently closed with funding decisions to be announced soon!

The report featured a project at Emma's Home Day Care facility, which included critical outdoor renovations to improve the health, safety, and quality of the outdoor space for children and families.

Take Action for Dedicated Child Care Facility Funds



High-quality child care facilities are essential to a healthy and sustainable child care ecosystem, yet there are currently no dedicated federal resources to acquire, construct, or majorly renovate child care facilities. Urgent action is needed and the National Children's Facilities Network (NCFN)'s website has a Take Action page with various resources and steps you can take to help support standalone child care facility funds. Dedicated, standalone funding is critical to help leverage other investments that are necessary to help support equitable access to high-quality early learning opportunities in our communities.

The Bipartisan Policy Center's *Why a Federal Investment in Quality Child Care Facilities is Necessary* includes the following talking points:

- 1. The safety and security of our nation's children is on the line
- 2. Parents can't go to work without child care facilities and there simply aren't enough

- 3. The early childhood workforce directly benefits from investments in child care facilities
- 4. Child care providers need dedicated federal funding to support the improvement and new construction of child care facilities
